

SUBGRANTING CALL LIST OF SELECTED ENTITIES

The **COMHOM Subgranting Call** has closed on the the **15th of July 2025**.

A total of **56 proposals** have been submitted.

The **evaluation and selection** has been completed on the **15th of October 2025**.

A total of **25 proposals** have been selected to participate in the COMHOM project. The list below is presented in **alphabetical order** and **does not reflect any ranking or scoring position**.

All eligible entities were evaluated by an **external panel of 5 members**. Each proposal was assessed independently by **3 evaluators**, who assigned a final score and provided comments on **relevance, quality and efficiency of implementation, project team and risk management, and impact**. Those who scored above 70 points were considered for the portfolio selection.

The portfolio selection was based on multiple criteria, including the **evaluation score, country of registration, welfare regime system, size, digital maturity, legal status, monitoring and evaluation (M&E) practices, network membership, and type of homelessness service provided**. The portfolio was composed to ensure **diversity and balance**, rather than statistical representativeness.
